## Overview

According to the Women and Equalities Committee recent [report](#) the Government has systematically failed Gypsy, Roma and Irish Traveller communities. After a lengthy inquiry revealed the extent of these failures the Government announced a new [cross-government strategy](#) to address Gypsy Roma and Irish Traveller inequalities. However little else has been shared and we are still waiting to hear what that strategy will look like or how it will be consulted upon.

A raft of evidence dating back decades highlights Gypsies, Roma and Irish Travellers experience some of the worst outcomes of any ethnic groups in the UK, across a wide range of social indicators. For example, the educational outcomes for Gypsy, Roma and Traveller (GRT) pupils are particularly poor. According to the [Race Disparity Audit](#), GRT children have the highest rates of school exclusion and the lowest attainment of all ethnic groups. They are overrepresented within the criminal justice system, and have some of the poorest health outcomes of any ethnic groups in Britain.

Despite inclusion within the Census 2011, coding has not been aligned, and key data collection and ethnic monitoring across public bodies and statutory services has remained woefully inadequate.

Without consistent ethnic monitoring and data collection it is impossible to put in place meaningful and impactful policies and targeted interventions that will improve access to economic inclusion opportunities, good and impactful healthcare outcomes, effective youth at-risk intervention measures, access to education and progression to third level, or adequate accommodation. This conference is community-led and will act as a consultation opportunity to devise a draft strategy, putting in place key recommendations, targets and desired outcomes to inform and influence the strategy.

What needs to happen – a strategy must be devised with community input if it is to be meaningful, impactful and sensitive to GRT community needs. Therefore, with community input, and embracing the slogan of '*what gets measured gets done!*', this year's conference will provide a platform for community members, public institutions and supporters to write the blueprint for the new cross-government strategy to tackle GRT inequalities. It will discuss the impact of weak data monitoring, hear the voice of communities and produce a report to inform the strategy.

# Workshops

**Economic Inclusion: From school to work:** *Chair: Brian Foster (ACERT & TM Trustee); Tyler Hatwell (London Gypsies and Travellers); Sarah Reis (Women's Budget Group)*

Members of Gypsy, Roma and Irish Traveller communities experience some of the starkest inequalities of all ethnic groups in the UK. In education Travellers of Irish Heritage and Gypsy/Roma ethnic groups have the highest rates of both fixed period and permanent exclusions. According to the 2011 census Gypsy, Roma and Traveller (GRT) of all ages have the highest rates of economic inactivity – men 39% and women 60%; 14% of GRT young people (16-24) are unemployed, the highest for any ethnic group. At almost a third, Gypsy and Irish Travellers were also most likely to be inactive (and not a student) at 31%. Only 30% of GRT young people are students, the lowest proportion for any ethnic group. This workshop will consider the above statistics, explore the contexts from community perspectives and come up with recommendations for the cross-government strategy for tackling GRT inequalities.

**We are speaking up, who is listening?:** *Chair: Prof Margaret Greenfields (Bucks New University); Caroline Buckley & Mark Penfold ('One Call Away' suicide/mental health helpline for Travellers); Martin Gallagher ( TM advisory board, Traveller mental health activist, PhD candidate); Lisa Smith (Traveller's Times 'It's Kushti to Rokker' project lead)*

According to Equality and Human Right's Commission [report](#) "Gypsies, Travellers and Roma were found to suffer poorer mental health than the rest of the population in Britain and they were also more likely to suffer from anxiety and depression". The alarmingly high suicide rate within the Gypsy Roma and Traveller (GRT) communities is a clear indicator that not enough is being done to address these issues. With appropriate intervention and investment by the Government, the negative mental health outcomes for GRT are reversible and avoidable. This workshop will pull together recommendations for the Government National GRT Strategy on how to tackle the mental health crisis affecting Gypsy, Roma and Traveller communities.

**Still invisible! The impact of data gaps in tackling GRT inequalities:** *Chair: Prof Colin Clark (University of West Scotland; TM Advisory Board); Natasha Codioli McMaster (London Plus); Christine Browne (Kings College London Widening Participation; TM Advisory Board)*

The Race Disparity Audit revealed the stark inequalities experienced by ethnic minority groups in the United Kingdom. However, of the 130 data sets examined by the audit, only 27 contained classifications relating to Gypsies, Roma and Irish Travellers (GRT). Despite ethnic monitoring in the 2011 census, too few public services, bodies and institutions have updated their monitoring systems to the 18+1 ethnic classification systems. How can we address the stark inequalities faced by GRT communities if we don't have the data? How do we embed good practice, and create data-informed policy responses if we don't have sufficient "proof" of these inequalities? This workshop will explore the evidence to hand, the insights gained from qualitative research, and how the Government can take forward data-driven responses in the new cross-government strategy.

**Still overlooked and overrepresented? Addressing Gypsy Roma Traveller disproportionality in the criminal justice system** *Chair: Jim Davies (formerly GRTPA and TM Advisory Board); Martin Campbell (Co-director GRTPA; TM Advisory Board); Jess Mullen (Policy Manager, Clinks)*

Prisoners of Gypsy, Romany and Traveller backgrounds are significantly overrepresented in the prison population. Traveller Movement research suggests that the proportion might be as high as 5% (the same proportion as women prisoners) and much higher than this in some establishments. TM research shows this proportion is even higher in secure training centres (STCs), which hold young people between 12 and 18 years old, with 12% considering themselves Gypsy, Romany or Traveller. In Medway STC in Kent, this figure was 22%. This research also indicates that the number of Gypsy, Romany and Traveller prisoners continues to be underestimated within the custodial estate. Furthermore, the distinct needs of this group are often not recognised and go unsupported. This workshop will examine the impact of poor data monitoring, the experience of GRT in prisons and suggestions for change to ensure effective support and rehabilitation.
